7. To maintain requisite standards for practitioners by way of education and training and to organise and hold appropriate examinations and issue qualifications.
8. Generally to participate at local level, by and through both social and technical events organised by branches. In particular, members may meet people engaged in similar work to themselves drawn from different firms and professions, to discuss matters of common interest and to learn how such matters are viewed from different perspectives.
